3. Free Registration
4. Must submit all competition applications in by 11/05/16.
5. There will be 3 rounds requires.
6. Must have 4 songs (1 from HSP, 1 Hmong New Year, 1 Free and 1 song if there should be a tie).
7. Competition will be 2 days
 - a. New Year Song
 - b. Free song
 - c. Final Round - HSP Song
 - d. Top three, If there should be a tie-there will be a 4th round
8. All songs must not be longer than 5 minutes.
9. Must provide your own customs and accessories.
10. Must provide your own CD with songs.
11. Top 3 Groups must be willing to participate and present in any future Hmong or HSP event(s) upon request.
