Requirements and Qualifications

1. This competition is open person of age 5 years old and up.
2. Participant must be amateur singers (must not be professional or belongs to professional group/band).
3. No Entry/Registration Fee.
4. Competition will be 3 rounds and 2 days (2 rounds on day-2 and final round on day-3).
5. Participants can register at least 45 minutes prior to the competition, at the stage at the New Year Field on Day-2/November 25th, 2016.
6. 4 Songs are required and must not be longer than 5 minutes each (1-slow, 1-fast, 1-Free and 1 song if there should be a tie).
 - a. Hmong New Year/Mountain Life – 1st day
 - b. Love Song -1st day
 - c. Free- 2nd day
 - d. If there should be a tie-there will be a 4th round
7. No foul language, inappropriate behavior, offensive language songs.
8. All Songs must be in Hmong Language only.
9. All Participants must comply with all HSP terms and conditions, requirements and Qualifications.
10. All Participants agree to be bound by rules and decisions of the judges.
11. All Participants must perform as a solo only.
12. Contestant must provide his/her own CD of background tracks.
13. All background tracks must be clean of vocal singers (instrumentals only).
14. All Contestants and family members are not allowed to have contact with any judges before or during the competition.
15. All judging will be on:
 1. Vocal Ability (rhythm/pitch/phrasing).
 2. Stage Presence (movement/confidence/command).
 3. Appearance (Costume/attire).
16. If there should be a tie between 2 contestants, there will be another round between the 2 contestants to break the tied.
17. Scores are available upon request. Signature(s) will be required.
