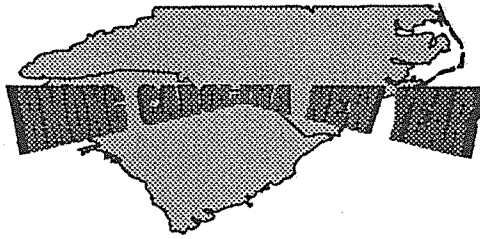



Peb tsis muaj teb muaj chaw, tsis muaj vaj muaj tse los noj lub tsiab pebcaug. Peb yuav ua li cas peb lub tsiab pebcaug thiaj yuav tsis ploj thiab khaws tseg qhia rau peb me tub me nyuam? Peb yuav ua li cas peb lub tsiab pebcaug thiaj yuav vammeej thiab muaj kev lom zem? Peb yuav ua li cas peb me tub me nyuam thiaj yuav sib pom, sib paub, sib fim ntsej fim muag? Lawv thiaj yuav tsis tso peb tej kev li kev cai, tsoos ris tsoos tsho, thiab lus Hmoob tseg es kom peb hais tau qhia luag lwm haiv neeg tias peb yog Hmoob? Kuv xav hais tias ntshe tsuas yog peb lub tsiab pebcaug lawm xwb...

Yog vim li cas thiaj hais li no? Lub tsiab pebcaug thiaj yog peb Hmoob ntiag tug lawm xwb. Yog peb muaj lub tsiab pebcaug noj txhua txhua xyoo, lub tsiab pebcaug yuav tsis ploj. Tsis tas li peb yuav ceev tau tseg pub rau peb me tub me nyuam. Yog thaum peb ua tau zoo lawm nws yuav muaj kev lomzem thiab vammeej. Tsis tas li yuav ua rau peb me tub me nyuam nyiam ces lawv yuav rog peb khaws lawm yav tom ntej. Tawm si yuav ua li cas peb thiaj li yuav muaj tsiab pebcaug noj txhua xyoo? Lub tsiab pebcaug yuav tsum muaj kev lom zem los yog muaj pau muaj ntsis thiab ua tau zoo nkauj. Cov nyiaj txais yuav raug xa rov qab rau nej tsis pub rhaug li ob hlis tom ntej noj pabcaug tag. HMONG CAROLINA NEW YEAR

Lub nrooj sib tham hnuv tim 9 lub 8 hli, xyoo 1992 no tau pom zoo tias peb Hmoob tsis ntshuav pov thawj dab tsis los hais tau tias peb yog Hmoob lawm. Tsuas ntshuav peb lub tsiab pebcaug lawm xwb. Yav tag los peb nyias noj nyias zej nyias zos. Ua rau peb muaj teeb meem thiab kev cov nyom ntau tsav ntau yam xws li: tuaj sib koom tsis tau, noj tsis muaj caij muaj nyoog, noj tsis muaj qab hau, thiab tsis muaj kev lomzem. Phem tshaj ntauw, tseem ua rau luag pej kum haiv neeg ceeb thiab thuam peb tias cas "Hmoob yuav muaj ntau lub peb caug ua luaj lid!". Yog vim li no, kom peb Hmoob muaj lub npe, kom luag lwm haiv neeg txhob luag thiab thuam peb, kom peb me tub me nyuam khaw tau peb kev li kev cai, thiab kom peb lub tsiab peb caug vam meej, peb cov muaj npe raws li nram no thiaj tau pom zoo kom peb noj pebcaug ua ke.

Cov muaj npe raws li nram nod tau txiav txim siab los tuav te ua ke ntxhawb qa peb Hmoob lub koob meej nyob yav qab teb sab hnuv tuaj. Peb thiaj tau los pom zoo tias cia:

1. Cov sawv cev (Board of Directors) los tuaj yeem qiv ib leeg \$100.00.
2. Thov qiv cov kwvtij neejtsa ib yig \$50.00.

coj los siv them qi tsev noj pebcaug, chaw ncaw thiab ntau pob, pub rau tub ncaw thiab ntau pob, pub rau cov ntsuab raj ntau ruas (BAND), pub rau cov tub ntxhais tuaj ua yeeb yam te taw, thiab lwm yam nyob rau lub tsiab pebcaug 1992.

Cov nyiaj hais los saum no yuav xa nrao qab rau tus tswv (\$100.00 los yog \$50.00) tawm sis yuav tsis muaj paj (interest). 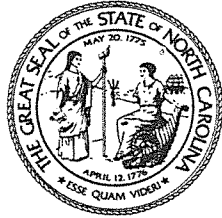

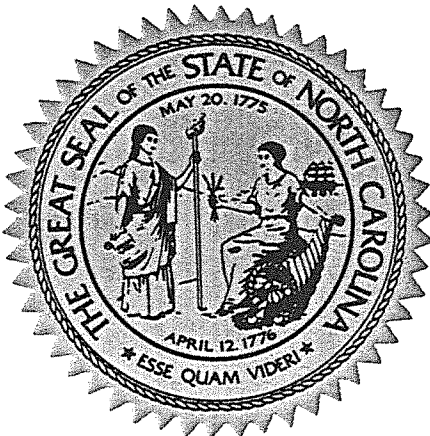
